Chairman's Report

Chairman Norris serves on the CPAC which is the Pre-K Council. He updated the Board regarding the staff and community members that make up the Council. The Pre-K grant application is submitted annually. It is complete and ready to be submitted to the State. Two grants are funded through the State of Tennessee and one through Shelby County Education Foundation.

Chairman Norris distributed to the Board a Notice of Findings from the State Comptroller's Office. The issues have been addressed and new plans are in place.

Chairman Norris announced that there will be a Board Work Session at 7 p.m. next Thursday, March 30th in the Bartlett High School Auditorium for Fleming Architects to present the Master Plan for the High School.

Superintendent's Report

Superintendent Stephens updated the Board that he is pursuing the option to combine the State of Tennessee Identification Numbers for the High School and the Ninth Grade Academy. One school number will assist in compiling testing results, reports, student data collection and eliminate confusion.

At the recent principal's meeting, the new math and ELA TN Standards were presented. Training will be provided by the State in April and throughout the summer. BCS will utilize the "train the trainer" model.

BHS students took the ACT last Tuesday. Funding was provided so that all 10th grade students were given a practice ACT test.

There are on-going issues with our busing service, Durham. Ken Demetriou, Debbie Rike and I met with the Vice-President and the Regional Manager of Durham last Tuesday. They are not meeting our requirements with the amount of drivers and being on time. It is a driver shortage issue and they are currently training additional drivers.

We are exploring the idea of a 4 day, 10 hour work week for six weeks in the summer for the 12 month employees. A survey was sent out today to poll the 12 month employees.

We have issued an RFP for custodial services. It is a man power issue with ABM which results in an employee shortage. We have divided the bid into three pods and the high school counts as two. So companies can bid on a pod of three schools, a pod of all schools or just one school.
