Questions and Responses for ANNUAL INSPECTION OF FIRE SPRINKLER SYSTEMS AND FIRE PUMP

Bid #FY24011

- 1. Per the bid description it states it is the intent of this bid to obtain firm prices for the annual inspections of Fire Sprinkler Systems and Fire Pumps. Am I to understand that this bid does not include fire alarm system testing (smokes, heats, pull stations, horn strobes, etc.? Although alarm devices such as valve tamper switches, waterflows, etc. will be operated during the fire sprinkler inspections and noted during this time of inspection. This bid does not include fire alarm testing. The valve tamper switch and flow switch should be tested.
- 2. Per the bid description it states it is the intent of this bid to obtain firm prices for the annual inspections of Fire Sprinkler Systems and Fire Pumps. Is there any mandate/requirement that the fire sprinkler system must be scheduled to perform the inspections and testing on the same date and time as the fire alarm inspection (by others). No it's not.
- 3. Per the bid description it states it is the intent of this bid to obtain firm prices for the annual inspections of Fire Sprinkler Systems and Fire Pumps. Does Bartlett City Schools have a particular schedule they prefer to have the annual inspections performed? We are assuming it is best to perform the inspection during a time when students are out of school such as in the months of June, July or August. When was the last annual inspection performed? It was done during Fall break 10-2023
- 4. Per the bid description it states it is the intent of this bid to obtain firm prices for the annual inspections of Fire Sprinkler Systems and Fire Pumps. Bid sheet (page 11) list the 10 Bartlett School Buildings and the type of sprinkler systems but does not provide if any of these buildings have fire pumps. Can you provide further information? The only school with a fire pump is the high school.
- 5. Per the bid description it states it is the intent of this bid to obtain firm prices for the annual inspections of Fire Sprinkler Systems and Fire Pumps. Found on page 10 Scope of work Item #3 states that after the award of the bid, the successful vender must notify Bartlett City Schools to schedule a complete NFPA mandated inspection examining the inside of the fire sprinkler piping. This examination must be carried out a minimum of every five (5) years. If this bid is to be for performing annual inspections, should not the bid sheet have a separate line item for the 5-year internal inspections at each building? See revised bid sheet.
- 6. When was the last 5-year internal inspection performed? 5 years ago
- 7. Will a Bartlett City Schools personnel be required and provided at no cost to fire sprinkler inspection contractor during all scheduled inspections full dedicated sole for the purpose of unlocking doors, placing fire alarm systems on test, for the signing of inspection reports, etc. What are the procedures we will be required to follow? The plant manager will at the schools will be able to do that.
- 8. Should there become a need for repairs and an electric lift and/or scaffolding be required to reach piping, will Bartlett Schools provide this or will charge this at the same agreed Mark Up % as parts? If we didn't have one at the school it would be the same as parts.
- 9. Are there any "Fire Pumps" at either of these #10 locations? 1 at high school.
- 10. The "Required & Approved Repairs" section of the bid sheet; would this be our hourly rate for any **additional** work/repairs other than the Annuals and 5yr internal? Yes
