Questions/Responses

Bon Lin Elementary:

- 1. Spec Section 071900 states water repellants to be applied to exterior and interior; however, drawings only state exterior please verify. Exterior only
- 2. Please provide exterior drawings/views if there is any outside painting. No exterior painting
- 3. Sheet A1.4 need count of existing trees and mascots in corridors. What is shown in the drawings are the only ones we are painting over. Otherwise, field verify.
- 4. Sheet A7.1 states yellow & red wainscot to remain please confirm that this will not require repainting or touch up. As noted under the 'Finish Notes' #13 states existing paint in renovated areas to receive a new coat of paint. You most match existing colors per school. This includes all corridor colors. Field verify colors per school since corridors have their own color.

Appling Middle:

1. Sheet A7.1 – will cloth canopy be removed & replaced by owner? No, you will be responsible for removing them and placing them back. Coordinate with owner where to store on site.

ALL Schools:

- Can you please provide detail of owner supplied graphic for "Home of ..." showing letter sizes/fonts? Refer to Addendum #1
- 2. Please provide ceiling drawings of all 3 schools so we can locate the gypsum ceilings and/or furr downs that need to paint. Field verify
- 3. Can you please provide a count of painted mascots in the gym in each school and/or provide photos of gym elevations showing painted graphics. Painted mascots are excluded in the scope. Noted on plans there will be a cap at each one. field verify all graphics locations. If existing graphics are damaged during the new painting job, you will be responsible for repairing it as new.
- 4. Can you please provide the ceiling height of the cafeteria and gym of each school. Estimated height Gym 25'-0" and Cafeteria 14'-0". Shall not be used for take-offs. Field verify exact heights.
- 5. Will owner applied and/or installed art/misc. items be removed by owner? If this refers to posters and paper graphics in the corridors, the school will remove these items before summer. If not, please clarify your question.
